Beverage Menus

The Emporium Hotel updates the beverage & cocktail menus on a seasonal basis. These menus are available in the Cocktail bar for your perusal. We are happy to work on a **consumption or bar tab basis** but do ask that the minimum spend be met to allocate an area. The minimum spends are outlined below. The beverages spend, along with your canapes selection must be pre paid prior to your booking. This final payment must be paid 48 hours before your event when final numbers are placed.

Required Minimum Spends (Sun – Wed)

Minimum spends apply for all Cocktail Bar bookings over 15pax:

- Bookings of 15pax is a minimum spend of \$750
- Bookings of 30pax is a minimum of \$1500
- Bookings of 40pax is a spend of spend of \$2000
- Bookings of 50pax is a minimum spend of \$2500

All bookings must be confirmed 2 weeks in advance & 48 Hours final notice for catering purposes.

50% of the minimum spend is required to confirm all bookings.

Required Minimum Spends (Thur – Sat)

Minimum spends apply for all Cocktail Bar bookings over 15pax:

- Bookings of 15pax is a minimum spend of \$1125
- Bookings of 30pax is a minimum of \$2250
- Bookings of 40pax is a spend of spend of \$3000
- Bookings of 50pax is a minimum spend of \$3750

All bookings must be confirmed 2 weeks in advance & 48 Hours final notice for catering purposes.

50% of the minimum spend is required to confirm all bookings. Final Payment is due 48 hours prior to your event.

Friday & Saturday Night Bookings

Bookings may not exceed 50 pax on a Friday and Saturday night due to capacity and hotel occupancy. We regret to inform that the Cocktail Bar does not take bookings under 15pax on Friday or Saturday Night.

Sunday – Thursday Bookings

Functions up to 70pax can be booked Sunday – Thursday at any time subject to availability.

Car Parking

1. Hotel Valet Car Park

Cocktail Bar Terms & Conditions

General Booking Information

- The bar must remain open at all times to hotel guests
- Night bookings must arrive no later than 7pm and may have the area until 11pm when their partition will be removed and all guests may enter the area.
- Cancellation of the booking within 1 week of the event date will result in loss of deposit.
- All food must be pre ordered and paid in full one week before the event. All food is non refundable.
- The Cocktail Bar does not provide any drink packages only full wine and cocktail menu's are available unless otherwise organised with the Bar Manager.
- All functions will receive their own waitress, bartender and exclusive use of the left hand side of the bar for the duration of their event.
- Standard liquor licensing rules apply and any overly intoxicated people being asked to leave the bar.

Dress Code

- Dress code is smart casual with no shorts or thongs allowed in the bar after 6pm unless the guest has had a serious injury which stops them from wearing trousers and jeans. No caps are allowed in the bar after 6pm Friday and Saturday.

18th and 21st Birthdays

- An extra charge will apply to cover extra security staff for your event
- An additional charge of bond may apply. This is up to the discretion of the hotel upon booking.
- The hotel reserves the right to insist on a minimum selection of canapes for your event to adhere to our Liquor Licensing responsibilities.
- The hotel reserves the right to cease service of alcohol or admission of entry to the hotel bar

Responsible service of alcohol

- In accordance with the liquor act, responsible service of alcohol will be practiced as Emporium Hotel Cocktail Bar. This requirement will be taken into consideration when determining client requests for beverages. Emporium Hotel is a licensed venue from 7am until 2am. No extensions allowed.

Smoking policy

- Emporium Hotel is a smoke free hotel & building. Guests and visitors are required to adhere to the Queensland Government Tobacco Laws. Please note that fines are applicable for persons in breach of the tobacco laws.
